

## VOLUNTARY CONTRIBUTIONS FORM

- **Government Relations Activities:** Funds support activities directed to increasing NAEA's name recognition and efficacy in promoting legislation that is favorable to enrolled agents and good for taxpayers.
- **Public Awareness Activities:** Funds support activities working towards increased public awareness of enrolled agents and the unique and valuable services EAs provide. This also includes the monitoring services for stories or quotes of EAs in the media, and distribution costs for national press releases.
- **Legal Defense Fund:** Funds protect the EA profession from legislation that may negatively impact our right to practice
- **Education Foundation Scholarship Fund:** Funds are combined with corporate sponsorship or royalties to provide scholarships for the prestigious National Tax Practice Institute™ (NTPI®) as well as to aspiring Enrolled Agents preparing to take the Special Enrollment Examination.
