FYI – There are two Hyatt hotels in the general area.

- Rate:** \$209 per night plus 13.25% tax. Rate includes in-room internet. For online reservations, go to: <https://aws.passkey.com/go/2018naeaprogram>. The discounted rate for NAEA shows up automatically. To make reservations by phone, call 1.888.421.1442. Be sure to mention the 2018 NAEA May meeting. If you need to do so, reservations must be cancelled 24 hours in advance. Check-in time is 3:00pm and check-out time is 12:00pm.
- Deadline:** **Reservation deadline is Friday, April 20, 2018.**
- Transportation:** The Hyatt Regency Crystal City at National Airport is approximately 1 mile from the airport. Cab fare is about \$10. It is also located on the Blue/Yellow lines of the Metro, about one-half mile from the Crystal City Metro station. A complimentary shuttle runs from the hotel to the airport and Crystal City Metro.
