Affiliate Mission:

To engage and empower enrolled agents at the state and local level through education, networking, and community events.

To advance the profession by promoting the EA credential, providing continuing education, leading state advocacy efforts, and providing leadership and volunteer opportunities for members.



NAEA and Affiliate Collaboration

- Affiliates and NAEA will engage through events, education, advertising, and leadership.
- Everyone works together professionally and collaboratively regarding legislation and regulatory issues related to the EA right to practice
- NAEA and affiliates will collaborate on strategic initiatives that elevate and support the EA profession.



State Affiliates Expectations

- Chartered as NAEA State Affiliates
- Separately incorporated nonprofits
- Individually governed by their own Board of Directors and Bylaws
- Maintain active corporate status in their state
- Follow state and federal tax laws
- File their own annual tax returns
- Manage own membership dues/renewals/roster
- Adhere to the state affiliate provisions in the NAEA bylaws



National Association of Enrolled Agents

Membership Operations

- Affiliates will perform all membership functions
 - Build a database or obtain an Association Management System (AMS)* to maintain member data
 - Create an online join process for new members
 - Create an online renewal process for renewals
 - Perform monthly and annual member communications and renewal functions

*NAEA will work with a group of affiliate representatives to evaluate AMS options and attempt to negotiate a group pricing model. NAEA will provide current membership data export and assist with the import of the data into the new AMS.



NAEA Commitments to Affiliates

- Working with affiliates to promote the EA credential
- Continue defending state-level EA right-to-practice issues
- Providing state-level advocacy assistance
 - Using NAEA Legal Defense Funds when appropriate
- •Training volunteers and affiliate leadership SSLA
- Promoting affiliate membership and programs
- Coordinating joint membership campaigns to new EAs
- •Supporting future EAs through the Education Foundation
- NAEA will not create a chapter in a territory that has an NAEA affiliate



Affiliates Commitments to NAEA

- Monitoring EA right-to-practice issues
- Providing member volunteer and leadership opportunities
- Promoting the EA credential
- Providing continuing education and networking for EAs
- Providing NAEA with updated affiliate leadership contact information annually
- Continuing to provide NAEA with annual form 990 Tax Returns and amended bylaws (if applicable)
- Promoting NAEA membership and programs



Affiliate Council Committee

- Continues to serve affiliates and NAEA
- •Serves as liaison between the affiliates and NAEA
- Monitors state-level advocacy issues
- Participates in semi-annually meetings with NAEA
- Includes an NAEA Board of Directors Liaison
- Communicates strategic initiatives between NAEA and affiliates



Affiliate Status

- Affiliate will notify NAEA of continuing affiliate status by (TBD)
- Affiliate may conduct member bylaws vote to remove the dual membership requirement
 - (This vote is at the Affiliate board's option.)
- Affiliate will establish a membership administration system by (TBD)
- NAEA will provide a final membership list and dues on (TBD)
- NAEA will inform all members of membership renewal options by (TBD)
- NAEA will encourage Enrolled agents to be members of NAEA and one or more state affiliates
- NAEA will provide links to Affiliate join pages on the NAEA join page
